NOTES:

- Original archaic and erroneous spellings have been preserved. Capitalization and punctuation may differ slightly from the original.
- At this point, I'm assuming that the fourth column of the valuation is for "Farthings." There were four farthings per penny, but so far I have not been able to decipher the amounts written for the two instances where that column was used.
- Due to a smudge or overwrite of the amount for the "Saddle and Bridle" I cannot be certain of the value, but if it is £7, then the total of all items comes to £251 13s 9p (and unknown farthings). In modern decimal notation that would be £251.6875. According to a paper by James Heldman, http://www.jasna.org/persuasions/printed/number12/heldman.htm one British pound in 1800, was worth \$4.44, which by 1988 would have been worth \$30.62. By extension, The Inflation Caclulator (http://www.westegg.com/inflation/) says that \$4.44 in 1800 would be worth \$60.87 in 2014.

Comparing with another online calculator, "Measuring Worth" http://www.measuringworth.com/calculators/ppoweruk/ it says that £1 in 1800 would be worth £70.45 in 2013. Then applying the average exchange rate from 2013 (1.5630), you get \$110.11 (exchange rate from http://www.oanda.com/currency/historical-rates/).

Therefore the estimated value of William's goods circa 2014, ranges from \$15,320.22 to \$27,713.31.

- There was a Jacob Johnson who married Sarah Carkhuff in Hunterdon Co., NJ, 24 Aug 1800 (New Jersey Marriages, 1684-1895).
- There was a Samuel Green of Amwell, Hunterdon Co., NJ, who died in 1797 (Calendar of Wills—1796-1800, p.148-9). This explains why the inventory refers to Sam's estate. According to an abstract of his will, he had grandsons named Jonathan Hoagland and Samuel Hoagland. A John Hoagland was named as one of three executors. Jonathan and Samuel were also grandsons of William Hoogland through his son, John Hoogland who married Elizabeth Green, daughter of Samuel.
- A John Prall Sr., of Kingwood, Hunterdon Co., NJ, died in 1813 (New Jersey Calendar of Wills—1810-1813, p.300). Possibly related to Mary Prall, wife of Issacher Hoagland (William's great grandnephew).
- Thomas West is most likely William's son-in-law (married to Mary).
- A Joseph Reading of Amwell, Hunterdon Co., NJ, died in 1806 (New Jersey Calendar of Wills—1806-1809, p.275). Also a Joseph Reading Jr. of the same place, died in 1810 (New Jersey Calendar of Wills—1810-1813, p.306).
- Joseph Hogaland could be William's brother or son (also "Joseph Hoogland").
- Derick Hogaland is most likely William's son (also "Derrick Hoogland/Hoagland").
- Amos Hogeland is most likely William's brother (also "Amos Hoogland").

• Richard Opdycke Esq. (1740-1825) was a Justice of the Peace in Kingwood, who married Grace Thatcher and had 12 children.
